- 2. Finance (Treasurer Team: Jeff and Bryan)**
  - a. Our year-over-year cost overrun has gradually come down (from about \$20K to \$15K in 2024 and down to about \$10K in 2025).
  - b. In 2024 we took in more than we did in 2025. Our overrun was 15K last year because our expense was much higher then. Our expense will continue to trend better as in coming down.
  - c. Currently we have received \$50,628.55.00 in contribution as of February 2026.
  - d. We've got a pretty good handle on the expenses. It all depends on the contribution coming in.
- 3. General Operations:**
  - a. Locations: Online (Website, Facebook, YouTube)
    - i. We've reached 170 countries since the inception of our online ministry.
    - ii. We have 94 (up from 85 last year) subscribers on YouTube.
    - iii. Facebook has combined friends and followers. Therefore, we have about 1,000 followers as of February 2026. (We no longer accept of the friend requests since many of them appeared to either be digital marketing or suspiciously spam-like.)
  - b. Fun Facts:
    - i. Over 50% of our website visitors use Chrome browser. Over 20% use Safari. The rest uses Firefox, Opera, Edge, and some other browsers.
    - ii. Our most popular pdf downloads in 2025 were the current lessons (e.g. Romans and Thessalonians) and the book of Daniel.
  - c. Prayers: Once a week, continue as-is
    - i. If we don't hear anything from anyone, we let the prayer request stay on the list for a while longer.
